# 2022 WATER QUALITY REPORT for the CITY OF McCALLSBURG

The city of McCallsburg strives to provide you with a safe, dependable supply of drinking water that is in compliance with the guidelines established by the Environmental Protection Agency (EPA). This report contains important information regarding the water quality of McCallsburg's water system. The city of McCallsburg purchases its water through a bulk connection with Iowa Regional Utilities Association (IRUA). The Marshalltown Water Works supplies the water to IRUA, which is pumped from nine deep wells located on the north side of the Iowa River drawing from the Buried Sand and Gravel and Pleistocene Aquifers. Our water quality testing shows the following results:

## **DEFINITIONS**

- Maximum Contaminant Level (MCL) The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- Maximum Contaminant Level Goal (MCLG) The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- ppb parts per billion

- RAA Running Annual Average
- Treatment Technique (TT) A required process intended to reduce the level of a contaminant in drinking water.

- Maximum Residual Disinfectant Level Goal (MRDLG) The level of a drinking water disinfectant below which there is no
  known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial
  contaminants.
- Maximum Residual Disinfectant Level (MRDL) The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
- SGL Single Sample Result

#### **GENERAL INFORMATION**

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water posed a health risk. Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The City of McCallsburg is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your drinking water, you may wish to have your water tested. # SOURCE WATER ASSESSMENT INFORMATION

Iowa Regional Utilities Association purchases the water it provides McCallsburg from Marshalltown Water Works. Marshalltown Water Works obtains its source water from the Buried Sand and Gravel and Pleistocene aquifers. The Buried Sand and Gravel and Pleistocene aquifers were determined to have low susceptibility to contamination because the characteristics of the aquifer and overlying materials provide natural protection from contaminants at the land surface. The Buried Sand and Gravel wells will have low susceptibility to surface contaminants such as leaking underground storage tanks, contaminant spills, and excess fertilizer application.
